



CCXAP assigns Logan Group Company Limited's US dollar-denominated senior notes final BBB_g- rating

Hong Kong, 19 October 2020 -- China Chengxin (Asia Pacific) Credit Ratings ("CCXAP") has assigned Logan Group Company Limited ("Logan" or the "Company") (BBB_g-/Stable) USD300 million 5.25% senior notes due 2025 a final BBB_g- rating.

The notes are senior obligations of the Company, guaranteed by certain of its existing subsidiaries. The notes are at least pari passu in right of payment with the existing pari passu notes and all other unsecured and unsubordinated indebtedness of the Company. The Company intends to use the net proceeds for refinancing certain of its existing indebtedness.

CCXAP's final rating on the notes follows Logan's completion of its USD bond issuance, of which the final terms and conditions are consistent with expectations. The final rating is in line with the expected rating assigned on 12 October 2020.
