




### **CNH HIBOR and SHIBOR Spreads**

As of 24 July 2015, the CNH HIBOR fixings were higher than that of SHIBOR for tenor of overnight, one week and six months and one year while their fixings for tenor of two weeks, one month and three months were lower than that of SHIBOR.
